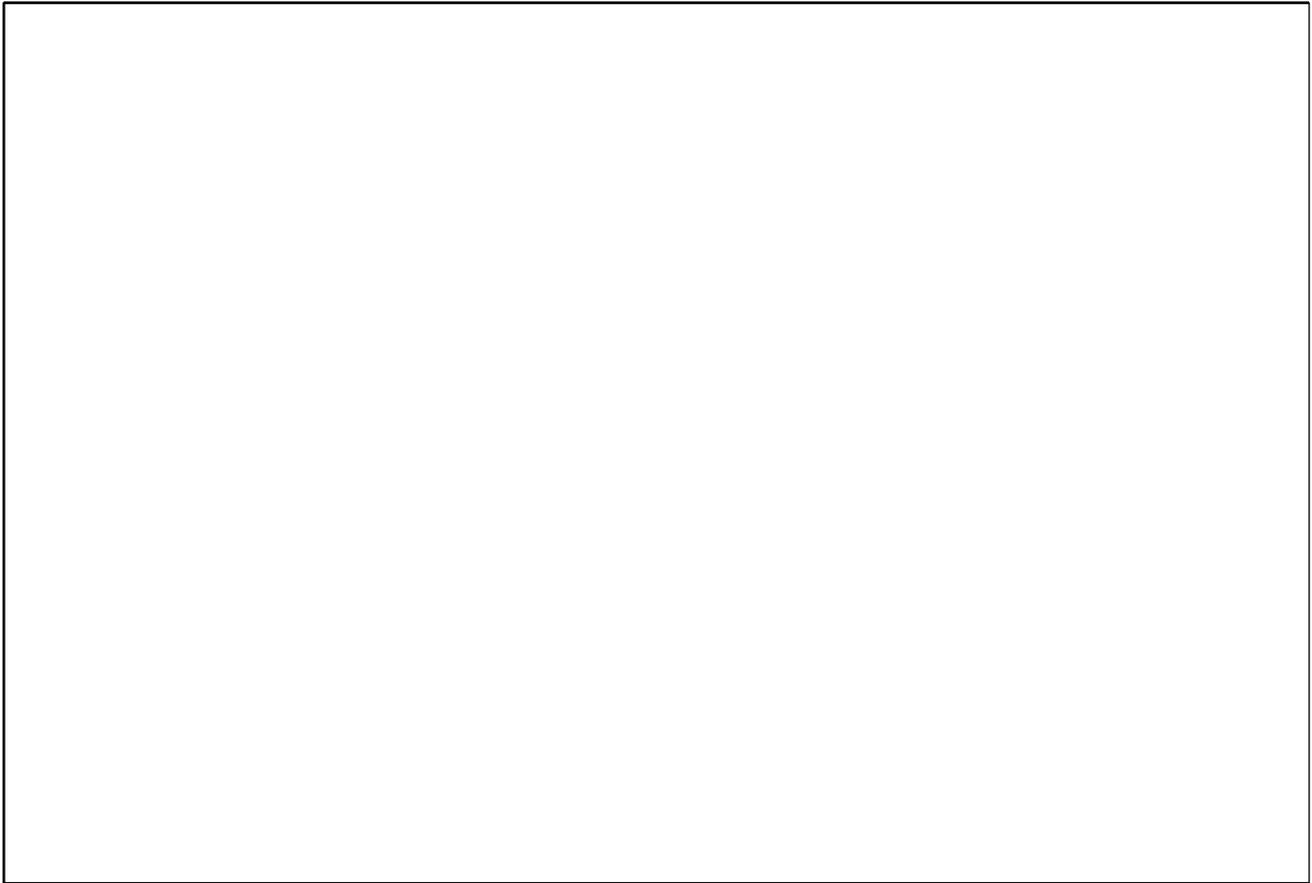

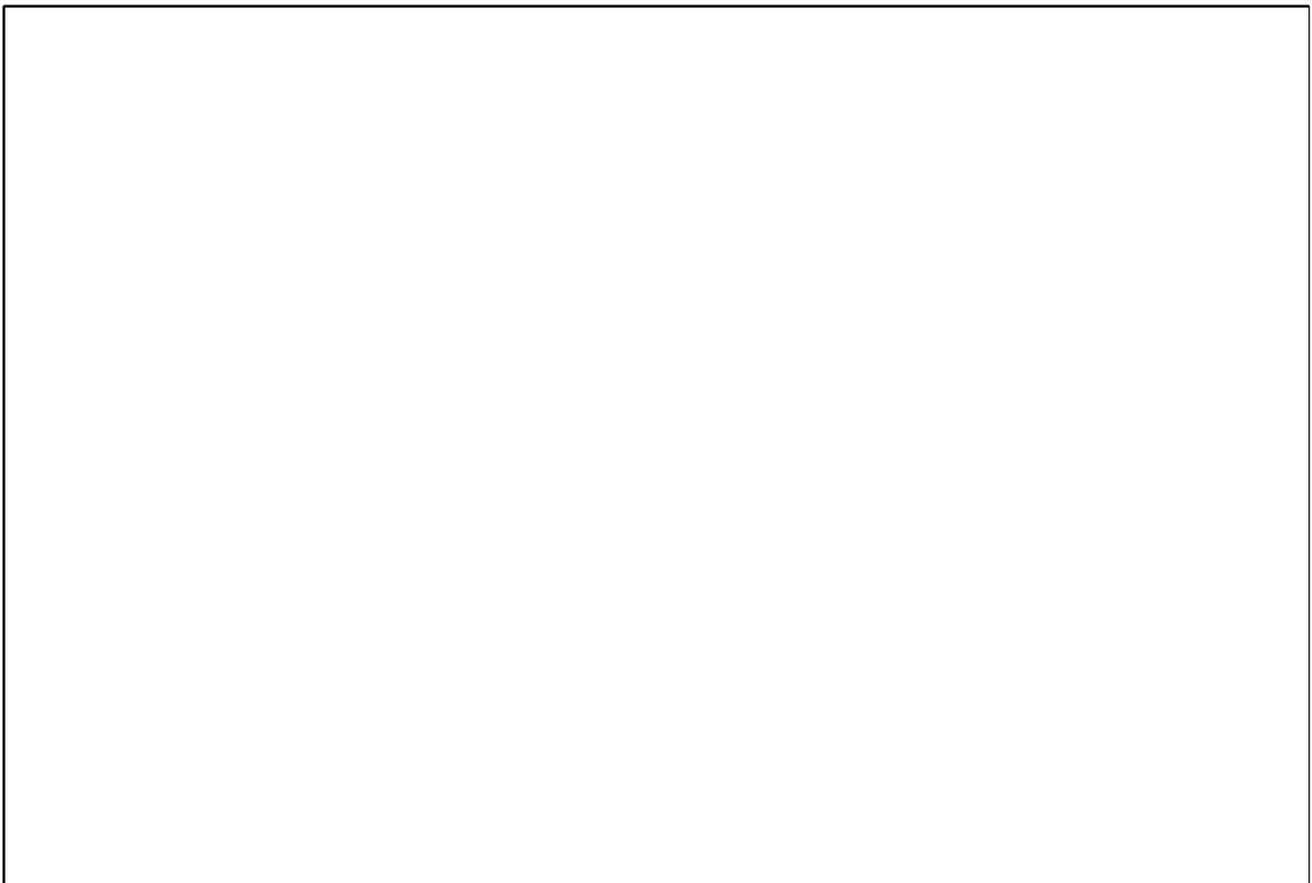

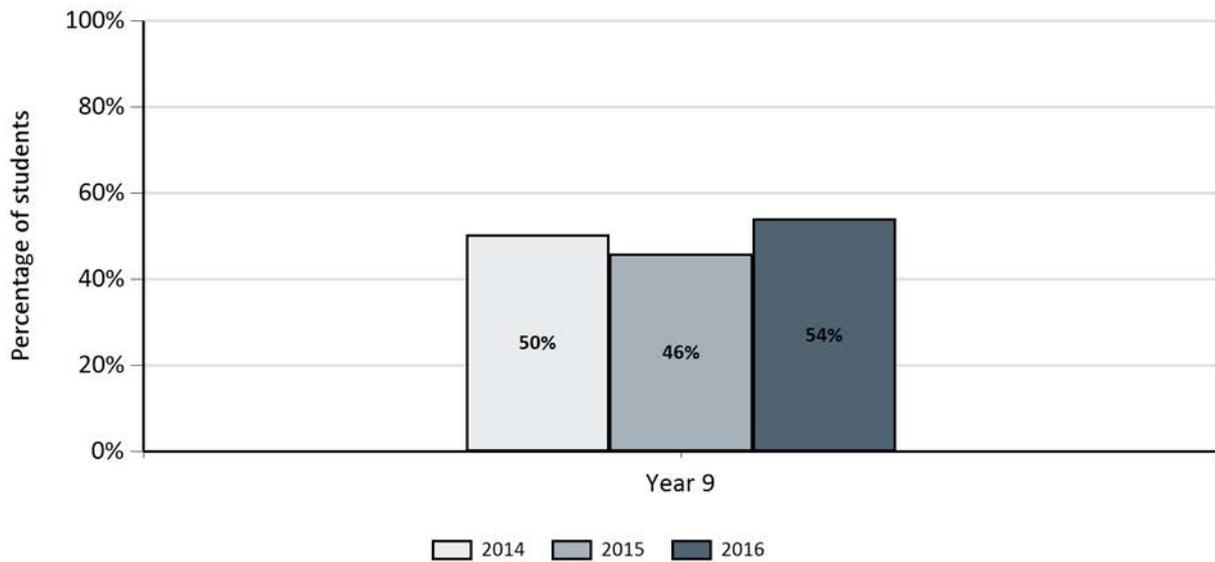

NAPLAN Proficiency

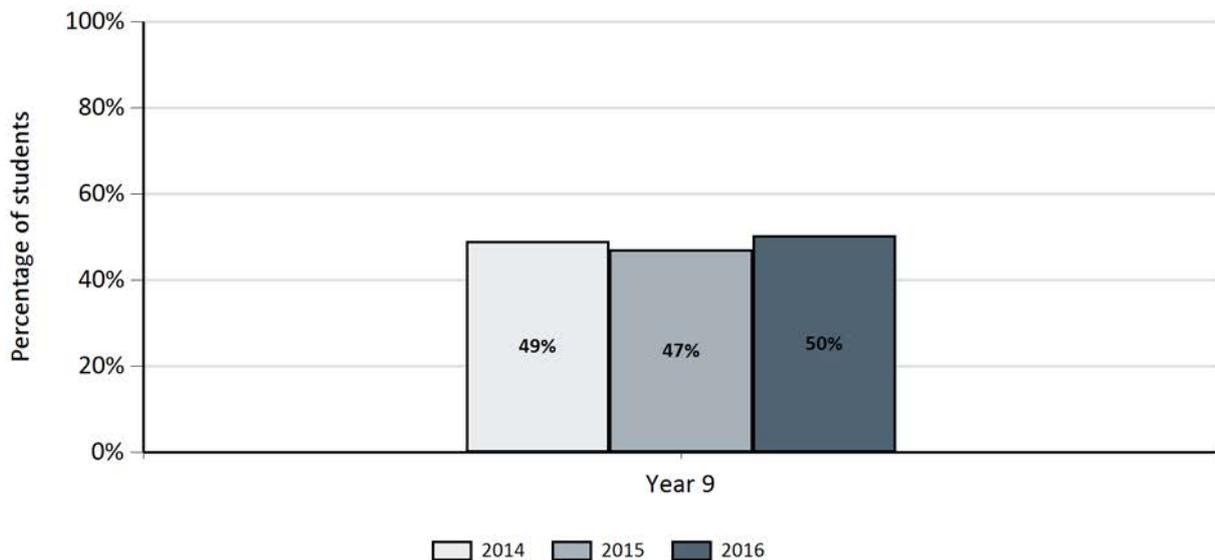
